Announcements from the Chair:

Citizen's Open Forum:

Jared Weber, 42 Golden Hill Rd – attended Lee Select Board meeting with GE representatives, happy to hear that a board member attended asked why other members did not attend. Asked about communication to the public about submitting responses to the T&D plan. Asked for evidence that Lenox is working with the other towns.

Debbie Kelly, West St – Attended Lee meeting as well. Disappointed that the Selectman present did not participate or comment.

Roberta Bianco, 39 Golden Hill Rd – Also attended Lee meeting. Asked if the Board favors trains over trucks for transportation of sediment. She doesn't think Lenox residents know how to submit their comments about the T&D plan.

NM talked to connecting Weston and Sampson with the residents of the Town to create an impactful response in addition to individual responses from Lenox residents.

Paula Dowling, Lasher Ln – Still a large percentage of people that don't know what's going on. Asked if it was appropriate to make a comment at Special Town Meeting.

Matt Ruddick, Golden Hill Rd – Expressed concern and pessimism that the board is not being straightforward with citizens. Asked who signed the agreement and what would have happened if the Board hadn't signed the agreement. Asked why the Board wouldn't announce the response period during the Special Town Meeting.
