JB brought the meeting to order at 5:35PM.

Scott Shortt described the scope of the project at 51 Church Street/21 Housatonic Street:

Certificate of Appropriateness for renovations at 51 Church Street/21 Housatonic Street, Map
43 Parcel 178. Review and vote on a proposed addition and renovations. The proposed addition
is approximately 16'x28' and proposed renovations to the existing building include new entry
doors, new decking, new stairs, removal and alteration of existing windows and other
improvements.

PA wanted to confirm the address, and map/parcel were correct. JB indicated he believed they were correct.

KD expressed concerns regarding the appropriateness of the addition, specifically the roof. KD also questioned the size of false window on the Church Street elevation (Elevation #3). PJ also had concerns about the addition.

The HDC discussed different roof options with the applicant. The applicant agreed to consider additional roof options for the addition and provide updated drawings to the HDC.
