- Jim Biancolo (JB), Mark Smith (MS) and Ariel Smith (AS) from the sign bylaw subcommittee reviewed some of their suggestions to the bylaw with the Planning Board.
- MS stated that the document shared with the Planning Board are what was found that may be in conflict with the draft sign bylaw the subcommittee is working on.
- JB reviewed the suggestions that the sign bylaw subcommittee found when reviewing the Agricultural Uses bylaw.
- The Planning Board will incorporate comments/suggestions into the proposed bylaw during their next meeting on March 23, 2021.

# 6. Discuss upcoming Lenox ZBA petitions for 48 Main Street and 52 Main Street (scheduled for March 17); discuss next steps including whether to provide comments.

- Gwen Miller, Town Planner, shared a document with the Planning Board on Review Criteria for the Planning Board when the Board wants to comment on applications for Special Permits and Variances. The Board reviewed the criteria provided by GM.
- KMV concerned that upstairs/downstairs units in the village are going to become transient housing and lose the opportunity for year-round residents.
- KMV questioned the use of the variance on the 48 Main Street application. She does not believe that it meets the variance standard.
- PK stated that use variances, which is what the applicant is requesting at 48 Main Street, are
  not allowed under state law unless the municipality calls out the allowance of use variance
  in their own zoning bylaws.
- PK asked the Board if any members have a desire to send anything to the ZBA as correspondence for the petition. TD needs to read through applications again. LF needs to review use variances and needs more time to review the applications. It was agreed that PK and KMV would work on a formal comment and LF may join in.
