PK opened the meeting at 6:00pm. The meeting was recorded by the Planning Board and by Mr. Fanto of the Berkshire Eagle.

1. Continue discussion of proposed changes to sign bylaw (1 hour)

- MS and JB reviewed changes to the sign bylaw in the document named "Proposed Sign Bylaw 3-22-2019"
- MS noted that the sequence of current bylaws is not set in stone and will change as the board moves through the edits.
- MS & AS created an illustrations document for the PB and reviewed them with the members as they relate to each section of the proposed new sign bylaw.
- PK suggested and showed a proposed draft putting all the signs allowed in each district on to one page so that a user could reference one sheet and understand what they can and cannot do in regards to signage. Alternatively, the Board could use this format as an analytical tool as it works to streamline signs issues by district.
- MS noted that while walking around the village he noticed that merchants will hang signs from other signs and made the changes to the bylaw for permit not required, acknowledging that some of the proposals made in the new bylaw are proposed based on what businesses truly seem to find beneficial.
- 1.1.1 table will change "mass highway" to Mass DOT
- PK wants to review 1.1.2.3 in regards to signs, plaques and tables
- Section 1.1.3.3 is new to the bylaw

- Section 1.1.4 was pulled into its own section within the bylaw
- TD suggests that within 1.1.5.2 design requirements; section 2 should be broken out into three other sections. MS made note to make changes to document.

• ACTION ITEMS

 - PK reviewed key elements of Planning Board requirements on Citizen Petitions under state statute. These include holding a public hearing to receive citizen comment and following with a written report from Board to a Town Meeting.
 - Planning Board set Public Hearing date for April 23rd at 6:00pm
 - TD motions to approve notice of public hearing presented by Land Use Director. KS seconds. Motion passed unanimously (4-0).
 - ACTION ITEM
 - PK to confirm that town counsel will review citizen petitions before Planning Board public hearing.
 - PK to confirm printing deadlines to get PB comments into Town Warrant at ATM.
