at 7:00 o'clock p.m., then and there to act upon the following articles, except Article 15, by posting an attested copy of this Warrant therefor in three public places in the Town not less than seven days before the 5th day of May next.

The polls for voting on the ballot on Monday, May 9, 2022 will be open at 7:00am and will be closed at 7:00pm.

ARTICLE 1...

To see if the Town will vote to waive the reading of the warrant and return of service thereof and to authorize the moderator, pursuant to MGL Chapter 39, Section 15, to declare a 2/3rds vote on voice votes if he deems it so; or take any other action in relation thereto.

ARTICLE 2.

To see if the Town will vote to raise and appropriate or transfer from available funds in the treasury, money for the operating expenses of the Town for Fiscal Year 2023 as follows, or any other sum; and, further, to provide for said appropriation, transfer the sum of \$524,000 from Free Cash, so called, as Certified on July 1, 2021; or take any other action in relation thereto.

We, the registered voters of the TOWN OF LENOX, hereby petition that the following Warrant to Ban the Sales of animals raised in "puppy mills" be placed on the TOWN WARRANT, for the upcoming TOWN MEETING. Under the ordinance, "no pet store shall sell, deliver, offer for sale, barter, auction, give away, or otherwise transfer or dispose of cats, dogs, or rabbits" unless they come from an animal control center or animal shelter, maintained by or under contract with any state, county, or municipality, whose

mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes or rescue organizations; or take any other action in relation thereto.

### A REGULATION REGARDING THE SALE OF DOGS, CATS, AND RABBITS IN PET STORES

WHEREAS, Most puppies, kittens, and rabbits sold in pet stores come from large-scale, commercial breeding facilities where the health and welfare of the animals is disregarded in order to maximize profits ("puppy mills," kitten mills," and "rabbit mills" respectively). According to The Humane Society of the United States, an estimated 10,000 puppy mills produce more than 2 million puppies per year in the United States.

WHEREAS, The documented abuses endemic to puppy, kitten, and rabbit mills include over-breeding; inbreeding; minimal veterinary care; lack of adequate food, water and shelter; lack of socialization, exercise and enrichment; lack of sanitation.

WHEREAS, Pet store puppies are often sick and have behavioral problems because of the substandard conditions they were likely born into; they were taken from their mothers at a very young age; they were transported in trucks filled with other young puppies; they were placed in a pet store cage with or near other puppies who are often sick.

WHEREAS, Pet stores often mislead consumers as to where the puppies, kittens, and rabbits in the stores came from and make false health and behavior guarantees. Many consumers end up paying hundreds or thousands of dollars in veterinary bills and suffer the heartbreak of having their new pet suffer, and in some cases pass away.

WHEREAS, According to the U.S. Centers for Disease Control and Prevention, pet store puppies pose a health risk to consumers, as over one hundred Americans have contracted an antibiotic-resistant Campylobacter infection from contact with pet store puppies.

WHEREAS, Current federal and state regulations do not adequately address the animal welfare and consumer protection problems that the sale of puppy, kitten, and rabbit mill dogs, cats, and rabbits in pet stores pose. Federal oversight of the commercial breeding industry is severely lacking.

WHEREAS, Prohibiting pet stores from selling dogs, cats, and rabbits is likely to decrease the demand for puppies, kittens, and rabbits bred in puppy, kitten, and rabbit mills and decrease the burden that pet store puppies, kittens, and rabbits that end up in animal shelters place on local agencies and taxpayers.

WHEREAS, The huge majority of pet stores, both large chains and small, family-owned shops, are already in compliance with the proposed bylaw as they already do not sell dogs, cats, and rabbits but rather profit from selling products, offering services, and in some cases, collaborating with local animal shelters and rescues to host adoption events.

WHEREAS, This bylaw will not affect a consumer's ability to obtain a dog, cat, or rabbit of his or her choice from an animal rescue, shelter, or breeder who sells directly to the public.

WHEREAS, The City Council believes it is in the best interest of the City to adopt reasonable regulations to reduce costs to the City and its residents, protect citizens who may purchase cats, dogs, or rabbits from a pet store, help prevent inhumane breeding conditions, promote community awareness of animal welfare, and foster a more humane environment in the City.

#### Section 1. Definitions

Animal care facility means an animal control center or animal shelter, maintained by or under contract with any state, county, or municipality, whose mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes or rescue organizations.

Animal rescue organization means any not-for-profit organization which has tax-exempt status under Section 501(c)(3) of the United States Internal Revenue Code, whose mission and practice is, in whole or in significant

part, the rescue and placement of animals in permanent homes. This term does not include an entity that is a breeder or broker or one that obtains animals from a breeder or broker for profit or compensation.

Breeder means a person that maintains a dog, cat, or rabbit for the purpose of breeding and selling their offspring.

Broker means a person that transfers a dog, cat, or rabbit from a breeder for resale by another person.

Cat means a member of the species of domestic cat, Felis catus.

Dog means a member of the species of domestic dog, Canis familiaris.

Flea Market means a building, structure or open area occupied by one or more vendors, other than retail stores, for sale to the public of new or used goods or products on a seasonal, limited or full schedule of operation.

Offer for sale means to sell, offer for sale or adoption, advertise for the sale of, batter, auction, give away or otherwise dispose of a dog, cat, or rabbit.

Pet shop shall have the meaning as provided in section 1 of chapter 129 of the Massachusetts General Laws. Such definition shall not include an animal care facility or animal rescue organization, as defined.

Rabbit means a member of the species of domestic rabbit, Oryctolagus cuniculus.

#### Section 2. Restrictions on the Sale of Animals

No pet store shall sell, deliver, offer for sale, barter, auction, give away, or otherwise transfer or dispose of cats, dogs, or rabbits. Nothing in this section shall prohibit pet stores from collaborating with animal care facilities or animal rescue organizations to offer space for such entities to showcase adoptable dogs, cats, or rabbits provided the pet store shall not have any ownership interest in the animals offered for adoption and shall not receive a fee for providing space for the adoption of any of these animals.

No person shall sell, exchange, trade, barter, lease, or display for a commercial purpose any dog, cat, or rabbit on or in any street, roadside, public right-of-way, parkway, median, park, other recreation area, commercial parking lot, flea market, or other outdoor market, or commercial or retail parking lot, except for a dog, cat, or rabbit displayed by a shelter of animal rescue organization or as part of a 4-H program or similar exhibition or educational program.

#### Section 3. Record Keeping and Disclosure

Each pet shop shall maintain records sufficient to document the source of each dog, cat, or rabbit the pet shop acquires for at least two years following the date of acquisition of each dog, cat, or rabbit. Such records shall be made available, immediately upon request, to any Animal Control Officer, Police Officer, and/or Sanitation Inspector or Code Enforcement Inspector.

Each pet shop offering space for animal care facilities or animal rescue organizations to showcase adoptable dogs, cats, or rabbits shall post, in a conspicuous location on the cage or enclosure of each animal, a sign listing the name of the animal care facility or animal rescue organization from which each dog, cat, or rabbit in the cage or enclosure was acquired.

#### Section 4. Enforcement

The Lenox Animal Control (and its Lenox Animal Control Officer(s)) and the Lenox Police Department, shall

have the authority to enforce all violations of these sections. Any animal being offered for sale or transfer, or displayed for adoption in violation of these sections, may be seized or impounded. If the enforcing officer determines that failure to seize or impound the animal would be detrimental to the safety and/or health of the animal, the animal shall be seized.

Animals seized pursuant to this section will be held for a period of seven days. The person or entity in violation of these sections may file for an administrative hearing to appeal the seizure within seven days of the seizure of the animal(s). If, after seven days, the person or entity fails to file an appeal, the animals shall be surrendered to the Town Of Lenox Animal Control.

#### Section 4. Penalty.

A pet store that violates this section shall be subject to a civil penalty of \$500, and each dog, cat, or rabbit offered for sale or transfer, or displayed for adoption in violation of this section shall constitute a separate violation.

#### Section 5. Severability.

If any section, subsection, paragraph, sentence, clause or phrase of this bylaw shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this bylaw which shall continue in full force and effect, and to this end the provisions of this bylaw are hereby declared to be severable.

#### Section 5. Effective Date.

This bylaw shall become effective 90 days after passage.
