Quick Facts: Community Services and Facilities

Key Public Services

Lenox provides a range of services to its residents, carried out by the following departments, commissions, and individuals:

- **General Government:** Town Manager, Assessing Department, Housing Authority, Inspections Department, Town Accountant, Town Clerk, Town Collector, Land Use and Town Counsel.
- **Public Safety:** Fire Department, Police Department and Emergency Medical Services.
- **Education:** Superintendent of Schools, Public School System, grades pre-K through 12.
- **Public Works:** Department of Public Works, Animal Control, Recycling/ Solid Waste Services, Cemetery Division, Highway Division, Wastewater Division and Water Division.
- **Human Services:** Housing Authority, Tri Town Health, Veteran's Agent, Community Center, Youth Commission, Commission on Disability and Council on Aging.
- **Culture and Recreation:** Public Library, Parks and Recreation, Conservation Commission, Historic District Commission, Community Preservation Committee and Land Management Committee.

Public Schools:

- Lenox operates two public schools ; one elementary (PK-5) and one high school (6-12).
- In the 2014-15 school year a total of 728 students are enrolled in Lenox's public schools.
 - Lenox Memorial High, 406 students
 - Morris Elementary, 322 students
- In 2014 Lenox's expenditures per pupil was \$16,000, higher than the state average of \$14,021.

Water/ Sewer

- Water Division responsibilities:
 - improvement and maintenance of the Town's forty-eight miles of water main
 - average day flow of 0.73 MGD and a peak flow of 1.4 MGD
- Sewer Division Responsibilities
 - operates a wastewater treatment facility at 239 Crystal Street and three pump stations
 - average daily flow of 1.8 MGD and a peak flow of 4.1 MGD.
 - 76,000 linear feet of sewer lines
