

Minutes of Meeting – June 27, 2018; meeting called to order at 7:00pm. Present: Ken Fowler; Dave Roche; Warren Archey; Ed Lane; Neal Maxymillian.

Community Garden: Tom Romeo stated that the Lenox Community Garden Group would like to utilize a 40'x70' piece of land located on the back side of the chapel. He is envisioning 4x8 raised beds, with as many as 30 beds being able to fit in this footprint. A storage shed would also be needed. The Board was all in favor of utilizing this piece of property. MOTION by DR, seconded by NM to allow the Lenox Community Garden group to use town land directly behind the chapel and Academy Building for a community garden. 5/0 vote.

Tub Parade: The Tub Parade is seeking \$3200 from the Town to support this event. EL questioned if this is town money well spent. KF asked what would happen if the Town money went away, to which Maureen Gamelli stated that the Tub Parade would not occur. DR suggested \$2500 from the Town and the group reach out to the Chamber and Merchants Group for funding. MOTION by DR, seconded by NM to grant the amount of \$2500 to the Tub Parade. 5/0 vote.

BOS Reports: NM stated that school is now out for the summer, graduation was very nice and that the new superintendent search was very successful. He mentioned that the Planning Board met last night regarding the short term rentals; the Permanent Building Committee had met to discuss the Center School, the wastewater treatment plant and a public safety building; the Community Preservation Committee met, and that applications for funding are due in September. WA stated that he is working with Bill Gop on problem trees. DR stated that the library summer programs are in full swing, and that the VFW will be selling poppies on 7/3 on West Street. EL stated that Henry Avenue has now been paved, and that the DPW continues to work on capping the landfill. KF went through the June employment anniversaries.

By roll call, DR, EL, KF, NM and WA voted to go into Executive Session at 7:57pm to discuss the Town's strategy with respect to ongoing litigation, (EPA Rest of River Cleanup), strategy with respect to collective bargaining (Lenox Firefighters Association) and strategy with respect to other potential litigation.
