2. Discussion with Linda Shafiroff regarding her properties at Housatonic & Hynes Street. She will be submitting a Form-A/ANR plan in the near-term future and would like to give a summary overview of the lots in question prior to submission.
3. Annual reorganization of Board:
 - a. Election of Chair and Vice-Chair
