NC opened hearing at 7:30pm. The meeting was recorded.

1. Notice of Intent – 70 Bramble Lane (Map 1 Parcel 48) – continued from August 5, 2021

- Shannon Boomsma submitted a request for a continuance.
- DF moves to continue until September 2, 2021. MS seconds. All in favor 6-0.

2. Notice of Intent – 0 Sargent Brook Road (Map 1 Parcel 24) – continued from August 5, 2021

- Mike Kulig updated the Commission on the remediation of the property due to the Enforcement Order.
- The majority of top soil has been removed; down to native plants.
- The beach sand has not been removed yet. Still a pile of sand that needs to be removed.
- Bridghe McCracken from Helia Land Design presented the replanting plan to the Commission
 including review of native plants, shrubs and trees proposed on the property and the proposed plan
 to restore the area. There will be roughly seven trees and upwards of 40 shrubs planted.
- The Commission discussed that they would like to see more than seven trees replanted as the owners
 of the property had removed many more than seven trees prior. The Commission agreed that 12 trees
 would be sufficient.
- There was discussion around installing a boardwalk on the property down to the water. The
 Commission asked Bridghe and Mike to report back in a month on the replanting plan as well as if in
 fact a boardwalk would be installed.
- Planting to most likely start in October.
- DL moves to accept plan presented with addition of 5 trees for a total of 12 trees. RFC seconds. All in favor 6-0.
- DF moves to continue until September 16, 2021. RFC seconds. All in favor 6-0.

3. Discussion regarding Conservation land on E. Dugway Road

- Shawn Leary Considine came before the Board to discuss the Hashim property on the corner of
 Pittsfield Road and East Dugway and the possibility of the Town purchasing said land to conserve and
 keep open space. SLC presented a letter of intent in which the Chair of the Commission has the
 authority to sign to allow for a 45-day window for the Town to determine if in fact they would like to
 purchase the land.
- RFC moves to have NC sign the letter of intent. DF seconds. All in favor 6-0.
