Subject: Specific Bequest of Hans R. Fehlmann for Kennedy Park Memorial Fund

Dear Ms. Marra,

As we discussed today, my father, Hans R. Fehlmann, a resident of Lenox since the 1960s, died on March 7, 2022. In accordance with his Last Will and Testament, the John Drummond Kennedy Park has been devised \$50,000 "to be used for its general purposes." Accordingly, as my father's Personal Representative, enclosed is a check from his estate for \$50,000 made out to the Kennedy Park Memorial Fund (a Town-designated or trust account specifically for the Park).

For many years after his retirement from General Electric, my father and a neighbor, Gilbert Guy, enjoyed walking together to and through Kennedy Park from their homes on Post Road. My father frequently observed how the Park was a wonderful place to get exercise and to have long discussions with his close friend, Mr. Guy. My son and I visited the Park in the days following my father's death and were soothed by the Park's woods, vistas, and trails. The Kennedy Park Committee and the Town have shown good stewardship of the Park. Hopefully, my father's bequest will assist the Committee in sustaining the Park for future generations.
